Financial Assistance Procedures and Application

POLICY STATEMENT

Therefore, all applicants will be asked to pay a portion of the program fee. Financial assistance will be granted to the extent that resources are available. PAA reserves the right to refuse assistance to any applicant.

FINANCIAL ASSISTANCE FOR RHAPSODY HIP-HOP SUMMER ARTS CAMP

All RHAPSODY Hip-Hop Summer Arts Camp Financial Assistance Applications must include a completed camp registration form, a \$25 application fee, and copies of 2007 W-2 forms and a completed and signed copy of your most current 1040 form with all attached schedules, as submitted to the Internal Revenue Service.

All applications will be processed by July 23, 2008.

HOW TO APPLY

To apply for financial assistance, please complete the following steps:

- Complete the registration form located on the camp flyer.
- Complete and sign the Financial Assistance Application.
- Enclose copies of 2007 W-2 forms and a completed and signed copy of your most current 1040 form with all attached schedules, as submitted to the Internal Revenue Service.

Please note: Your application for financial assistance will not be processed unless all forms are submitted. A completed registration form and \$25 application fee are required.

SELECTION PROCESS

Eligibility for financial assistance will be determined by the Progressive Arts Alliance Board of Directors based on a thorough review of submitted applications. Applicants will be notified of the status of their financial assistance request by July 23, 2008. Final registration payments (less financial assistance and \$25 application fee) will be due in full on August 4, 2008, the first day of camp. Financial assistance will be granted only to the extent that funds are available. PAA reserves the right to refuse assistance to any applicant.

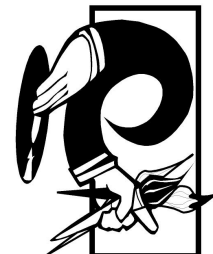

This chart can be used to estimate the financial assistance you may receive using this chart, based on your family size, monthly gross income (MGI), and the camp registration fee. For example, if you have a family of three and your MGI is \$1950 or less, you would qualify for 75% financial assistance. You would pay 25% of the registration fee.

Find the column that represents your family's size; move down that column until you find the amount nearest your MGI; move across that row to the right to determine the portion of the fee you will be responsible to pay. PAA would cover the remaining balance of the fee.

You will be notified of the status of your financial assistance by July 23, 2008. Should you receive financial assistance, your registration fee contribution payment will be due in full on the first day of camp on August 4, 2008. Your \$25 application fee will be applied to your reduced registration fee.
